## **Opportunity Summary:**

The Health Resources and Services Administration (HRSA) is accepting applications for the fiscal year (FY) 2022 Early Childhood Developmental Health Systems (ECDHS): Evidence to Impact program. The purpose of this program is to advance statewide systems of comprehensive early childhood developmental promotion, screenings, and interventions that improve outcomes and reduce disparities in early developmental health and family well-being for communities with high levels of childhood poverty. These systems will be referred to as early childhood development (ECD) systems throughout this notice of funding opportunity (NOFO).

One award will be made, in the form of a cooperative agreement, to establish an Early Childhood Evidence to Impact Center, hereby referred to as the Center. The goals of the Center are to: 1) increase the implementation and evaluation of evidence-informed, equity-focused strategies among states by providing national technical assistance (TA) and supporting the implementation and evaluation of ECD systems-building efforts; and 2) strengthen the evidence base in support of ECD systems-building.

This NOFO also describes an activity that will be supported with additional funding, pending availability of funds, to advance the delivery of high-quality ECD promotion and support services in pediatric settings. Through this additional activity, the Center will provide national leadership, TA, coordination, and evaluation in support of the anticipated Transforming Pediatrics for Early Childhood (TPEC) program, as further described in Appendix D of this NOFO and HRSA-22-141, when published. The application's overall score will be based on the response to all information requested in this NOFO, including the potential additional TPEC TA Activity; therefore, all applicants are expected to respond to this opportunity for additional funding, as well as the core program elements.

## **Eligibility & Requirements:**

• Eligible applicants may elect to collaborate with each other to jointly develop, implement, and evaluate the proposed program. HRSA supports such an approach when it appropriately increases efficiency and scale of proposed activities. In these cases, the application must be submitted by one eligible applicant that proposes to provide subawards to other eligible applicant(s) to jointly develop, implement, and evaluate this program.

#### **Internal Nomination Process:**

Interested applicants should submit the following documents:

- 1. JHU Limited Submission Cover Sheet
- 2. Proposal (maximum of two pages of text only, single spaced: 12-pt font and one-inch margins) (Note: figures, tables, and other reference material may be included in addition to the 2 pg. text limit)
- 3. Curriculum Vitae of investigator, including current external research support and publications
- 4. Budget (two pages maximum)
